## FREQUENTLY ASKED QUESTIONS

**Q When must my voted ballot be returned?**

**A** Ballots must be RECEIVED at the Adams County Election Office, or Voter Service & Polling Centers, or designated Mail Ballot Drop-Off sites by 7 pm on Election Day in order for your vote to be counted. Ballots received after 7 pm on Election Day will not be counted. **Postmarks do not count as a received date.**

**Q Where can I drop-off my ballot?**

**A** There are 14 drop-off sites, listed below, conveniently located around the county.

**Q How can I get a mail ballot?**

**A** All American Constitution, Democratic, and Republican Active voters will be mailed a ballot between June 2 and June 6, 2014. If you do not receive a ballot and believe your voter status is Active, please call the Election Office at 720-523-6500. An Election Specialist will review your record to help determine your eligibility to vote in this year's Primary Election.

**Q How can I tell if I am registered to vote?**

**A** Access [www.govotecolorado.com](http://www.govotecolorado.com) website and click on **View my Registration** status.

**Q I haven't received my ballot yet, who should I call?**

**A** The Adams County Election Office at 720-523-6500, open from 7am – 5 pm, Monday through Friday, exclude holidays.

**Q How much postage does my ballot require?**

**A** If you return your ballot in the envelope provided with only the ballot and secrecy sleeve, the 1<sup>st</sup> class postage cost to mail the ballot is **\$.49**. If you add any additional papers, the postage cost may increase.

**Q I accidentally spoiled my ballot. How can I get a new one?**

**A** You may request a replacement ballot by visiting one of the conveniently located Voter Service & Polling Centers listed below.

**Q How can I find Election Night results?**

**A** Unofficial results will be posted on the [www.adamscountyelections.org](http://www.adamscountyelections.org) website starting at approximately 7:30 pm, Election Night, June 24, 2014.

## VOTER SERVICE & POLLING CENTERS and MAIL BALLOT DROP-OFF SITES

**VOTER SERVICE & POLLING CENTERS:** Centers are open from 7am–5pm, Monday-Friday, 9am–2pm on Saturday, June 21; and, on Election Day, June 24 from 7am–7pm. Beginning June 4, 2014, voters may:

- **Affiliate** with a party for the Primary Election **if currently unaffiliated**
- **Register** to vote
- **Surrender** mail ballot and vote on an accessible voting machine
- **Replace** spoiled, defaced, or lost ballots
- **Drop off** voted mail ballots, **signed by the voter**
