## FREQUENTLY ASKED QUESTIONS

### Q. When must my voted ballot be returned?

A. Voted ballots must be in the possession of the Clerk and Recorder by 7pm on Election Day, August 10, 2010. Postmarks do not count.

### Q. Where can I drop-off my ballot?

A. There are fifteen drop-off locations conveniently located around the county listed below.

### Q. How can I get a mail ballot?

A. All Affiliated Democratic, Republican and Libertarian Active and Inactive-Failed to Vote voters will be mailed a ballot between July 19 and July 22, 2010. If you did not receive a ballot and believe your status is in one of the two listed, please call the Election Office at 303.920.7850. An Election Specialist will review your record and help determine your eligibility to vote in this year's Primary Election.

### Q. How can I tell if I am registered to vote?

A. Access the [www.adamscountyelections.org](http://www.adamscountyelections.org) website and click on **Check Your Voter Status**.

### Q. I haven't received my ballot yet, who should I call?

A. Call the Adams County Elections Office at 303.920.7850. We are open from 7am until 5pm, Monday through Friday, excluding holidays.

### Q. How much postage does my ballot require?

A. If you return your ballot in the envelope provided with only the ballot and secrecy sleeve, the cost to mail the ballot is \$.44. If you add any additional papers, the postage cost will increase.

### Q. I accidentally spoiled my ballot. How can I get a new one?

A. There are six locations, listed below, in Adams County where you may request a replacement ballot.

### Q. How can I find Election Night results?

A. Unofficial results will be posted on the [www.adamscountyelections.org](http://www.adamscountyelections.org) website starting at approximately 7:30pm Election Night, August 10, 2010.

## SERVICE CENTERS AND DROP-OFF LOCATIONS

**SERVICE CENTERS:** Six Service Centers will be open from 8am-5pm Monday-Friday (except Watkins 8am-4pm), 9am-2pm on Saturday, August 7<sup>th</sup>, and 7am-7pm on Election Day. At these locations, Voters may:

- Replace spoiled, defaced, or lost ballots,
- Surrender their mail ballot and vote on an accessible voting machine,
- Emergency-register,
- Drop-off their voted ballots,
- Affiliate with a party for the Primary Election if currently unaffiliated.
